會章修訂建議

現時會章第 66 條中“...such member shall be liable to expulsion from membership provided always that **Article 60** aforesaid is observed. ...”提及的會章第 60 條，內容與會章第 66 條並無關連，相信是過去修訂會章並增加章條數目時的文字編輯錯誤。查據 1998 年 12 月 18 日修訂的舊會章原來條文，現時會章第 66 條所提及的 **Article 60** 實際應是指現在會章中的 **Article 65**。因此執行委員會建議對會章作以下修訂，以確保會章有關條款在需要運用時能有效執行。

If any Member or Associate Member shall willfully refuse or neglect to comply with the provisions of the Constitution, or shall be guilty of conduct against the good name of the Club, such member shall be liable to expulsion from membership provided always that Article 60 aforesaid is observed. Any Member or Associate Member so expelled or excluded from membership shall have the right to appeal to the Regional Commissioner of the Hong Kong Island Region whose decision will be final.</p>	<p>EXPLUSION AND EXCLUSION FROM MEMBERSHIP :</p> <p>66. If any Member or Associate Member shall willfully refuse or neglect to comply with the provisions of the Constitution, or shall be guilty of conduct against the good name of the Club, such member shall be liable to expulsion from membership provided always that Article 65 aforesaid is observed. Any Member or Associate Member so expelled or excluded from membership shall have the right to appeal to the Regional Commissioner of the Hong Kong Island Region whose decision will be final.</p>

現時生效之會章（2012年6月9日修訂）相關條文：

60. The chairman of the General Meeting shall have a casting vote.

65. The Executive Committee shall have power by resolution to recommend to the President the expulsion or exclusion of any Member or Associate Member. Such recommendation shall contain all the relevant facts and grounds on which it is made and shall be accompanied by a copy of the resolution authorizing it. The President shall consider any such recommendation and shall take any actions as he/she deems expedient and shall forward a copy of the report in relation to the actions to the Executive Committee.

於 1998 年 12 月 18 日修訂的舊會章相關條文：

EXPLUSION AND EXCLUSION FROM MEMBERSHIP :

59. The Executive Committee shall have power by resolution to recommend to the President of the Club the expulsion or exclusion of any member of the Club. Such recommendation shall contain all the relevant facts and grounds on which it is made and shall be accompanied by a copy of the resolution authorizing it. The President shall consider any such recommendation and shall take action thereon as it deems expedient and shall forward a copy of report in relation to the action to the Executive Committee.
60. If any member shall willfully refuse or neglect to comply with the provisions of the constitution and by-laws of the Club, or shall be guilty of conduct against the good name of the Club, such member shall be liable to expulsion from membership provided always that Article 59 aforesaid is observed. Any member so expelled or excluded from membership shall have the right to appeal to the Regional Commissioner of the Hong Kong Island Region whose decision will be final.
